Mark Howson advised the meeting:

- Mid-Week Ride The planned mid-week run was also cancelled due to bad weather.
- October Run Northern Run Run Leader Howard Parslow. Meet at the Highbury Hotel 1017 North East Rd, Highbury, Tea Tree Gully at 9.00 am for a 9.30 am departure travelling to Williamstown Bakery for morning tea via Humbug Scrub. Returning to the Highbury Hotel for approx. 1.00 pm via Kersbrook and the end of the run.
- November Run 9<sup>th</sup> Run to Mannum for a Paddle Boat cruise and BBQ lunch catered for by the Mannum Rowing Club. Depart 'CCC' Clubrooms at 9.30 am arriving at Mannum for approx. 11.00 am. #### FEDERATION REPORT —

Brain Davey is the contact Department of Infrastructure and Transport (DIT) for the
Federation, if anyone has any issues regarding attempting to register an historic vehicle,
then it is best to not argue with the officers at Regency Park, politely cease your interaction
with them and contact Brain – he now has a direct contact in the department who will
advise him.

# Information from the DIT meeting.

- Keep MR334 forms for 5 years.
- DIT will be providing a check list in the future which will go out to Service SA centres for references to historic vehicles – for consistency across centres.
- DIT Vehicle Standards Manager is Lesley Emmett.
- o A vehicle must be running not trailered to go to Regency Park for inspection
- o To turn back a speedo apply for a certificate from Consumer Affairs.
- o Engine number need not be on a MR334 form providing it shows a vin or chassis number.
- o Vin plates or chassis numbers for car and motorbikes only applies after 1989.
- A Will must show vehicle/s as well as number plate/s
- Recent changes to the second-hand motor vehicle Act shows that up to four vehicles may be sold in a year or you need a licence to sell vehicles.
